- The board reduced the number of interested members list down to 20

- Nominations: Aubrey Malnourie (4), Kasey Anderson (6), Sharalyn Johns (1), Shelby Keplin (7), Jennifer Gonser (8), Sarah Selseth (5)
- Motion to approve the above nominations made by Liz Larsen, seconded by Beth Humenyik. Discussion held on comparable database users vs. HMIS users. Motion carried.
- 4. CoC Registration
  - a. Due to HUD on March 2, 2023 and was submitted on March 1, 2023.
  - b. Tribal Resolution was signed with Turtle Mountain Band of Chippewa.
- 5. CoC Funding Awards
  - a. All Tier 1 projects received the recommended funding.
  - b. Fargo Housing and Redevelopment Authority and Burleigh County Housing Authority both received their full funding from Tier 1 and Tier 2.
  - c. We did not receive the DV Bonus this year.
- 6. CoC Competition Debriefing
  - a. ND scored 132.25 out of 200.
  - b. In the upcoming competition, we will look at improvements in the System Performance and Coordination and Engagement sections.
  - c. ND scored 74.86 out of 100 on the DV bonus.
  - d. Both scores are below the median scores, but improvements have been noted.
- 7. CoC Spending Report (through September 2022)
  - a. 2018: \$42,257 has been recaptured by HUD. \$11,536 remains for the Capacity Building Grant which expires June 2023.
  - b. 2019: All grants have expired with a total balance of \$389,493. \$255,318 will be recaptured by HUD from Burleigh County Housing and Commerce. Remaining \$134,175 will also be recaptured.
  - c. 2020: \$1,669,691 in funds had not expired as of this date. \$540,558 have expired, however, \$322,941 expired at the end of December. YHDP funds were added to this amount.
    - Burleigh County Housing Authority is returning \$178,424.
    - Abused Adult Resource Center RRH has \$26,206 remaining and has potential to be returned.
  - d. 2021: Fourteen grant agreements have been signed as of this report. FHRA has not signed any grant agreements to date as their 2020 grants haven't expired yet. Red



River Valley Community Action Agency's grant has been transferred to Grand Forks Housing Authority.

# D. Policy Reviews and Approvals

- 1. Governance Charter
  - a. Changes to YAB committee section was approved by the YAB.
  - b. The Collaborative Application Memorandum of Understanding will be reviewed by ND Housing Finance Agency, the Board, and membership.
  - c. Motion to approve the Governance Charter by Jenna Richardson, seconded by Rob Johnson, no further discussion. Motion carried.
- 2. Emergency Transfer Plan
  - a. No significant changes.
  - b. Motion to approve the Emergency Transfer Plan by Mike Weatherly, seconded by Kayla Hochstetler, no further discussion. Motion carried. AARC's phone number needs to be updated.
- 3. YAB Compensation Policy
  - a. Mileage increased to match the state rate.
  - b. YAB approved the changes.
  - c. Motion to approve the YAB Compensation Policy made by Sue Shirek, seconded by Mark Heinert, no further discussion. Motion carried.
- 4. Written Standards
  - a. Added purpose section and key terms.
  - b. Updated General Standards. Two additional changes were made after the standards were sent out to the membership for review.



- Rent Reasonableness
  - CoC: Total rent for a unit assisted with CoC funds can exceed FMR if the rent meets rent reasonableness. For programs using leasing funds, rent paid using CoC funds may not exceed the lower of FMR or rent reasonableness. In situations where a unit is found to be rent reasonable, but the rent is above FMR, the recipient must use other funds, such as leverage (not match), to cover those costs. For programs using rental assistance funds, if rent reasonableness is higher than FMR, rental assistance funds can be used up to the amount of rent reasonableness.
- Category 3 was removed from eligibility because we do not have a waiver from HUD to prioritize this category.
- c. Project types were expanded to add additional information.
- d. Motion to approve the Written Standards made by Heather Ingman, seconded by Shelby Keplin, no further discussion. Motion carried.

## F. Regional Updates

- 1. Region 1
  - a. Coordinated entry has been a challenge, but Community Options has decided to step up in this process.
  - b. ND Rent Help (NDRH) program end has created some housing crises.
- 2. Region 2
  - a. NDRH program end has created some housing crises.
  - b. New clients from different states have been coming into the community.
  - c. Youthworks in Minot is on its seventh month of operating supportive services and transitional housing to youth 18-24! Out of our 6 beds we are housing 5 youth at this time with one opening. Just working on trying to utilize rapid rehousing funds and recruiting youth for the YAB.
- 3. Region 3
  - a. Turtle Mountain and Spirit Lake are making efforts to establish more homeless services. Turtle Mountain shelter is almost always at capacity.
  - b. Educating the community has been a priority.
  - c. Issues with NDRH.
  - d. Adequate housing is difficult to find.
  - e. Devils Lake shelter remains full.
- 4. Region 4
  - a. Seeing an increase in calls for emergency housing.
  - b. Financial assistance calls remain high.
  - c. Pembina bus plant closing is going to cause some concerns for that area; food insecurity has been an issue in rural areas and in GF
  - d. Mental health issues and medical issues are a challenge
- 5. Region 5
  - a. Shelters are in constant overflow.



- b. Downtown engagement center is seeing an average of 88 people per day for the month of April.
- c. Housing programs are full at the YWCA.
- d. City of Fargo just hired two new people between Harm Reduction and Emergency Management to work on strategic planning for emergency overflow.
- e. Safe Haven will be closed until the fall.
- f. SSRC will not be providing shelter until the fall.
- 6. Region 6
  - a. Influx of construction and workers, housing options will be minimal.
  - b. NDRH concerns
  - c. Eagle Flatts is almost completely full two 3-bedroom units are still available.
  - d. Great Plains Housing Authority is no longer providing deposit assistance.
  - e. Barnes County CHI received a \$25,000 Spark Grant to combat homelessness and SUD/SMI
- 7. Region 7
  - a. WARC (Beulah) is seeing a lot of NDRH ending and they are struggling to pay rent. Their shelter has been busy with DV cases and assisting those with emergency service dollars.
  - b. Burleigh County Housing Authority has several openings in their buildings, including PSH and Shelter+Care vouchers; short waitlist for HCV program.
  - c. Native, Inc. NDRH concerns are creating a crisis; increases in eviction notices, lack of second-chance housing providers; increase in substance use.
  - d. Drop-in center has changed hours. Will now close at 6 a.m. rather than 8 a.m.
  - e. Food pantries are busy, and supplies are extremely low.
  - f. Community Action is looking for carpenters for weatherization program.
  - g. NDRH is still open for homeless and at-risk applicants. Only the general assistance part of the funding has ended (per Jennifer Henderson).
  - h. One year anniversary of the Dream Center
  - i. United Way Center for Opportunity opening
    - Added individual sleeping rooms for families, shower space, laundry services, private space for families during the day, 24/7 space including access to computers and a printer, access to vital documents, onsite child watch by YMCA, peer recovery supports, onsite behavioral health services, and care coordination improvements.
  - j. Homeless Coalition identified top three unmet needs: childcare, transportation, and low barrier shelter and they are working to develop plans to find resolutions to the needs.
- 8. Region 8
  - a. Sexual assault numbers have increased dramatically, specifically pediatric sexual assaults.
  - b. Discussion on addiction and mental health issues being central to many issues being experienced in each region.
- 9. Statewide



- a. Community Options has been connecting with Department of Corrections at both state and county levels to meet with individuals who are preparing to release from the correctional facility. Aim is to reduce recidivism.
- b. ND Dept of Public Instruction. Title IV and Stronger Connections Grant awarded \$10 million to 14 schools to help with chronic absenteeism.

  - b. July 1, 2023: Date of transition from Commerce to NDHFA for ESG and NDHG.



- Concerns about gaps in funding NDHFA is looking to HUD to provide direction on whether expense reimbursements are a possibility.
- Taking applications for NDHG funds prior to transition has been suggested changes in regulations and funding amounts make this difficult.
- Working with Commerce on current processes to find what needs adjusting and what is working.
- c. Allocation plans are expected to be released by the end of this week.
- d. Pre-application trainings were requested by Sue Shirek.
